Business Interruption Insurance not only compensates you for lost income, it also covers operating expenses like electricity and other utilities and services that continue even though your business has stopped while recovery takes place. It normally becomes effective 48 hours following the event that caused the business to halt operations. Recovering from an event like a fire can take a while, so the limits of the coverage should cover your company for a reasonable length of time. We know that every company is different, and we'll tailor the coverage to suit your requirements. For example, a lawyers' office will be less vulnerable to a fire than a restaurant – plus it'll be a lot easier for the legal firm to be up and running in another location.

Axis Insurance is able to provide different types of business interruption coverage to suit any type of business. We include insurance based on profits, actual loss sustained, or gross earnings. We can also arrange coverage for the additional costs of professional fees needed to establish the amount of loss, should a claim have to be made. In addition, business interruption insurance from Axis can be extended to include interruption due to loss of power, as well as interruption resulting from damage which occurs at your suppliers' or customers' premises.
